c. Trustee Brink motioned to approve **RESOLUTION #866 to IMPOSE LATE PENALTY**CHARGE ON PROPERTY TAX COLLECTIONS equal to 3% of the tax on all taxes paid after February 14 and before March 1. Trustee Overweg seconded the motion which passed unanimously with a roll call vote:
