Business Items:

Zoning Administrator Report: Building permits for October included 9 new homes with a total declared value of \$2,956,013.

Committee Reports:

- a. <u>PLANNING COMMISSION</u> The construction of a private drive "Cicada Lane" from 72<sup>nd</sup> and Felch Street was approved along with the easement and road maintenance agreement. The site plan for Dollar General on the corner of 96<sup>th</sup> Ave and Adams was approved.
- b. **<u>FIRE COMMITTEE</u>** Presented a job description for a new part-time firefighter position.
- c. <u>BUILDING & GROUNDS</u> Presented estimates for the Community Center renovation to be reviewed by the next meeting.
- d. **PARKS & RECREATION** Starting on footings for the Drenthe Grove bathroom addition.

Supervisor's Report: Dead trees will be removed from the East Drenthe Cemetery sometime this winter.

Max Bus ridership is slow for the new bus route that goes through Zeeland Township. However, some of the stops were not viable because of road construction.

M121 Business Loop construction is wrapping up.
