6. Ottawa County Commissioner Al Dannenberg informed the board that the county approved a new 800 MHz radio system for Fire and Sheriff Departments. The County also approved placing a mental health millage of 0.3 mills on the March 2016 ballot. The proposed millage will be for 10 years.

7. Committee Reports:

a. **FIRE.**

- i. The fire committee approved leasing Firehouse software; a 5 year contract \$995/year.
- ii. There have been 462 calls so far this year.
- iii. Truck 671 will be trucked down to Alabama.
- iv. New truck No. 633 should be painted this week, get new tires and lighting.
- v. The Fire Department will try out a 1 year contract with Bio-Care fitness training.
- vi. Trail markers were installed on the mountain bike trails in the Macatawa Greenway.

- b. **ROADS** \$700,000 is budgeted for 2016 road projects.
- c. PARKS/RECREATION. A lot of wood has been removed from VanZoeren Woods.
- 8. Attorney Issues. None.
- 9. Supervisor's Report.
 - a. Utility Upgrades / Utility Financial Solutions. Mr. Mark Beauchamp will be conducting water and sewer rates study. He will be looking at meter fees, front foot rates, and trunkages. The study should be finished the end of June/July.
 - b. MTA Conference.

Treasurer Myaard motioned to approve per diem pay of \$40 per day for the four day conference. Trustee Barkel seconded the motion. Roll call: all ayes. Absent: Brink.

- c. Supervisor Nykamp thanked the board for another good year of work. He cited many of the projects completed in 2015.

- 11. Additional Board Comment. Trustee Overweg asked County Commissioner Dannenberg if there will be a marihuana proposal on the ballot next year. Mr. Dannenberg responded the state will submit a proposal to legalize marihuana.
