### ZEELAND CHARTER TOWNSHIP

# TRUCK ROUTE AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE TRUCK ROUTE ORDINANCE FOR THE CHARTER TOWNSHIP OF ZEELAND, OTTAWA COUNTY, MICHIGAN, BY EXPANDING THE DESIGNATED PROHIBITED TRUCK ROUTES.

THE CHARTER TOWNSHIP OF ZEELAND, COUNTY OF OTTAWA, STATE OF MICHIGAN, ORDAINS:

Section 1. <u>Prohibited Truck Routes</u>. Section 4 of the Truck Route Ordinance is restated in its entirety as follows.

### **Section 4: Prohibited Truck Routes**

No Person may operate a Truck, Truck Tractor, Truck Tractor and Semi-Trailer combination, or Truck Tractor and Trailer combination, on a Prohibited Truck Route. For purposes of this Ordinance, Prohibited Truck Routes are:

- A. 88th Avenue in the Township, north of Gentex North Riley Campus Drive to New Holland Street; and
- B. Quincy Street in the Township, between 64<sup>th</sup> Avenue and 72<sup>nd</sup> Avenue.

Section 2. <u>Effective Date</u>. This Ordinance was approved and adopted by the Township Board on August 16, 2016, after introduction and first reading on July 19, 2016, and publication after the first reading as required by Michigan law. This Ordinance shall take effect on October 2, 2016, the 31<sup>st</sup> day after publication of the Ordinance following its adoption.
