TOWNSHIP OF ZEELAND ORDINANCE NO. 117

An Ordinance to adopt by reference the National Electric Code, 1975 Edition. *9-29-77*

THE TOWNSHIP OF ZEELAND ORDAINS:

SECTION 1. NAME. This Ordinance shall be known as the Zeeland Township Electrical Ordinance.

SECTION 2. CODE ADOPTED. Pursuant to the provisions of the laws of the State of Michigan permitting same, the Township of Zeeland hereby adopts the National Electrical Code, 1975 Edition, as adopted by the National Fire Protection Association and hereby designates the Township of Zeeland to enforce the provisions of the Code adopted.

SECTION 3. REPEAL OF CONFLICTING ORDINANCES. All former Ordinances or parts thereof conflicting or inconsistent with the provisions of this Ordinance or of the Code hereby adopted are hereby repealed.

SECTION 4. VALIDITY CLAUSE. Should any section, paragraph, sentence or words of this Ordinance or of the Code hereby adopted be held for any reason to be valid, such holding shall not be construed as affecting the validity of any remaining portions of such section or of this Ordinance, it being the intent that this Ordinance and this Code shall stand.

SECTION 5. EFFECTIVE DATE. This Ordinance and Code hereby adopted shall be effective upon publication thereof.
