ORDINANCE NO. 145

ELECTRICAL CODE ORDINANCE

AN ORDINANCE to adopt the National Electrical Code, and to repeal certain ordinances inconsistent with this Ordinance.

THE CHARTER TOWNSHIP OF ZEELAND; OTTAWA COUNTY, MICHIGAN ORDAINS:

Section 1. Adopted by Reference. Pursuant to the provisions of Act 230 of the Public Acts of 1972, as amended. the National Electrical Code, 1984 edition, published by the National Fire Protection Association, is hereby adopted by reference and made a part of this Ordinance as if fully set forth herein.

Section 2. <u>Definitions</u>. Whenever the words "governmental bodies exercising legal jurisdiction over electrical installations" or "authority having jurisdiction of enforcement of the [National Electric] Code" are used in the National Electric Code, or whenever such governmental units are referred to in the National Electric Code, they shall mean the Charter Township of Zeeland.

Section 3. <u>Fees</u>. Electrical permits and inspections shall be required in the following circumstances listed in Table 1. The fees for electrical permits and the required inspections shall be as set forth hereinafter.

Section 4. <u>Severability</u>. This Ordinance and the various parts, sections, subsections, sentences, phrases and clauses hereof are hereby declared to be severable. If any part, section, subsection, sentence, phrase or clause is adjudged unconstitutional or invalid, it is hereby declared that the remainder of this Ordinance shall not be affected thereby.

Section 5. <u>Administrative Liability</u>. No officer, agent, employee or member of the Township Board or Board of Appeals shall render himself personally liable for any damage that may accrue to any person as a result of any act. decision or other consequence or occurrence arising out of the discharge of his duties and responsibilities pursuant to this Ordinance.

Section 6. <u>Penalties</u>. Any person who shall violate any provision of the National Electric Code, or of any permit issued pursuant to the provisions of such Code, or who takes any action requiring a permit hereunder without obtaining such, shall be guilty of a misdemeanor punishable by a fine not in excess of Five Hundred (\$500) Dollars, plus costs of prosecution, or by imprisonment in the Ottawa County Jail not in excess of ninety (90) days. or both such fine and imprisonment in the discretion of the court.

Section 7. <u>Enforcement Procedures</u>. The Township Board for Zeeland Charter Township, the duly authorized attorney for the Township, the prosecuting attorney for Ottawa County, or any owner or occupant of any real estate within the Charter Township of Zeeland may institute injunction, mandamus. abatement or other appropriate action or proceeding to prevent, enjoin. abate or remove any violation of the National Electric Code. any amendment thereto or any permit issued thereunder. The rights and remedies provided herein are cumulative in addition to all other remedies provided by law.

Section 8. <u>Repeal</u>. This Ordinance shall repeal Zeeland Charter Township Ordinance No. 104. Ordinance No. 117, Ordinance No. 119, Ordinance No. 129 and all other ordinances or parts thereof which are in conflict with any of the provisions of this Ordinance as of the effective date hereof. This Ordinance shall not repeal any other Zeeland Township ordinances.

Section 9. Effective Date. This Ord-nance was approved and adopted by the Township Boar: don N_{CV} . • 19-. 19-, after introduction and a first reading on 0^{cm} . /5 • 19=. 10: and publication after such first reading as required by Michigan Act 359 of 1947. as amended. This Ordinance shall take effect upon publication.
