ZEELAND CHARTER TOWNSHIP BOARD MEETING JUNE 15, 2021

The Zeeland Charter Township Board held a Regular Board meeting on June 15, 2021 at 7:00 p.m. in the Township Hall at 6582 Byron Road, Zeeland, Michigan. Members present: Supervisor Oonk, Treasurer Veldheer, Clerk Kraak, Trustees Riemersma, Salisbury and Bosma. Absent: Brink

Supervisor Oonk called the meeting to order. Recited the Pledge of Allegiance. Invocation offered by Trustee Riemersma.

Treasurer Veldheer motioned to approve the minutes of the June 1, 2021 meeting. Trustee Salisbury supported the motion which passed.

Business Items:

- a. Clerk Kraak motioned to approve <u>ORDINANCE #416 SIGN ORDINANCE</u> <u>AMENDMENT</u>. Treasurer Veldheer seconded the motion which passed with a roll call vote:
 - AYES: Oonk, Veldheer, Kraak, Riemersma, Salisbury and Bosma. Absent: Brink
- b. Great Lakes Energy requested approving an ordinance for a new franchise agreement. This is considered a first reading.
- c. Trustee Salisbury motioned to approve Paul Kuiper to the Fire Committee. Trustee Riemersma seconded the motion which passed.
- d. Treasurer Veldheer motioned to approve the low bid proposal from B&B Fire for the light tower project on Unit 633 for \$28,945.52. Clerk Kraak seconded the motion which passed with a roll call vote:

 AYES: Oonk, Veldheer, Kraak, Riemersma, Salisbury and Bosma. Absent: Brink.
- e. The Planning Commission recommended the rezoning of parcel #70-17-01-200-055 from Ag to C-1. This is considered a first reading.

Committee Reports:

- a. <u>PLANNING COMMISSION</u> Approved a final site plan review for Vriesland
 Crossings, approved with conditions a site plan review for Farmer's Co-Op, and
 approved a preliminary plat for Bluff Lakes Phase 5. Met for a work session to discuss
 zoning ordinance revisions.
- b. PARKS & RECREATION VanZoeren Woods is cleaned up and back in use.
- c. <u>ROADS</u> Due to vendor issues, brining on gravel roads has not taken place as scheduled. By switching to Great Lakes Chloride we can be added to their schedule for the week of June 28-July 3. They use a higher quality manufactured brine that is also more expensive than originally budgeted. Treasurer Veldheer motioned to approve spending approximately \$23,000 to Great Lakes Chloride for one application. Trustee Riemersma seconded the motion which passed with a roll call vote: AYES: Oonk, Veldheer, Kraak, Riemersma, Salisbury and Bosma. Absent: Brink.

Supervisor Report: There will not be fireworks in Holland on July 4, but they will have a Community Celebration on August 20 with fireworks.
