Supervisor Oonk called the meeting to order. Recited the Pledge of Allegiance. Invocation offered by Trustee Bosma.

Treasurer Veldheer motioned to approve the minutes of the June 21, 2022 meeting. Trustee Riemersma supported the motion which passed.

Citizen Participation/Public Comment: Paul Kraus is running for Ottawa County Circuit Court Judge in the Family Count Division.

## **Business Items:**

- a. Mandy Cooper, Vice President of Strategic Initiates at Lakeshore Advantage, presented an annual report.
- b. Trustee Riemersma motioned to approve ORDINANCE #422 TO RE-ZONE PARCEL 70-17-17-200-035 FROM AGRICULTURAL TO INDUSTRIAL. Treasurer Veldheer seconded the motion which passed unanimously with a roll call vote:

- c. Trustee Salisbury motioned to approve \$400,482.02 for VanZoeren Woods and Drenthe Grove Park improvements. This includes a bid for construction from My-Con, Inc. for \$335,101, a quote of \$31,973.02 to Sinclair Recreation for a shaded picnic area with tables and benches, and a contingency of \$33,499.Clerk Kraak seconded the motion which passed unanimously with a roll call vote:

- d. Treasurer Veldheer motioned to approve <u>RESOLUTION #942 GREAT LAKES</u> <u>ENERGY METRO ACT.</u> Trustee Riemersma seconded the motion which passed unanimously with a roll call vote: AYES: Oonk, Kraak, Veldheer, Riemersma, Salisbury and Bosma. Absent: Brink.
- e. The Planning Commission recommended a revision of the Accessory Building Ordinance. This is considered a First Reading.
- f. Treasurer Veldheer presented quarterly financial reports and budget amendments. Clerk Kraak motioned to approve <u>RESOLUTION #941 AMEND 2022 BUDGET.</u> Treasurer Veldheer seconded the motion which passed unanimously with a roll call vote:

Industrial was denied as is does not fit the Master Plan and the infrastructure is not there to support development.

b. <a href="PARKS & RECREATION">PARKS & RECREATION</a> – A damaged slide at the Drenthe Grove will be blocked off for the season. The playground will be replaced next year. Tickets for the Drenthe Grove Chicken BBQ will be \$12.
