The Zeeland Charter Township Board held a Regular Board meeting on September 17, 2024 at 7:00 p.m. in the Township Hall at 6582 Byron Road, Zeeland, Michigan. Members present: Supervisor Oonk, Clerk Kraak, Treasurer Veldheer; Trustees Brink, Riemersma, Salisbury and Bosma. Also present: Manager Eggleston.

Supervisor Oonk called the meeting to order. Recited the Pledge of Allegiance. Invocation offered by Trustee Salisbury.

Treasurer Veldheer motioned to approve the agenda. Trustee Brink supported the motion which passed.

Trustee Brink motioned to approve the consent agenda. Trustee Salisbury supported the motion which passed.

Business Items:

a. Supervisor Oonk opened the public hearing for the 2025 Annual Budget. After discussion, Treasurer Veldheer motioned to close the public hearing. Clerk Kraak supported the motion which passed.

- c. Treasurer Veldheer motioned to approve <u>**RESOLUTION #978 REZONE DENIAL**</u> <u>**HUNDERMAN**</u>. Trustee Brink seconded the motion which passed with a roll call vote: AYES: Oonk, Kraak, Veldheer, Brink, Riemersma, Salisbury and Bosma.

Committee Reports:

a. <u>LIBRARY–</u> Our contract with Howard Miller Library needs to be renewed before December 31. The City of Zeeland will send a draft contract to Manager Eggleson in a few weeks.

Supervisor/Superintendent Comment:

- We are still waiting on final agreement for the Wyoming Water System water main project from the Ottawa County Road Commission.
- Have contacted Jamestown Township and City of Zeeland regarding bike path maintenance but will proceed with a bid package for snow removal to prepare for this winter season.
- PAR plan grant could provide 4-6 cameras to be added to Drenthe Grove Park.
- Consumers Energy will attend the October 1st Board meeting to further discuss the Campbell plant closure.

Public Comment: A concern was shared with the speed of drivers on 96th Avenue near Woodbridge Street. Additional policing was requested.
