BOARD MEETING
June 6, 2017**

The Zeeland Charter Township Board held a Regular Board meeting on June 6, 2017 at 7:00 p.m. in the Township Hall at 6582 Byron Road, Zeeland, Michigan. Members present: Supervisor Nykamp, Clerk Kraak, Treasurer Barkel, Trustees Brink, Oonk & Riemersma. Absent: Overweg

Supervisor Nykamp called the meeting to order.
Recited the Pledge of Allegiance.
Invocation offered by Trustee Oonk.

- 17-26** Motion made by Trustee Oonk to approve the minutes of the May 16, 2017 meeting. Treasurer Barkel supported the motion which passed.

Citizen Participation/Public Comment: Jim Marsh has concerns about noise issues near his property and how the noise ordinance is being enforced. John Oren shared his concerns and was also looking for suggestions on drainage issues on his property.

- d. **ROADS** – Subdivision projects are going out for bid next week. Byron Road will be closed starting June 12 to run sewer across the street. Trustee Oonk suggested the bridge on Quincy between 64th and 72nd Ave needs to be fixed.
